## Data protection – the most important facts in brief

DR-WALTER Versicherungsmakler GmbH is an expert in insurance for private and business travel and stays abroad. As an insurance broker, we offer solutions that are tailored to you and your needs. The protection of your personal data is very important to us.

### Purposes of processing

Processing only takes place to the extent necessary to fulfill the consulting and brokerage mandate, in particular for needs assessment, risk assessment, or customer care. In addition, we process data for the purposes of combating abuse, as well as for advertising, market research, and opinion polling.

### Categories of personal data

Depending on the type of contract, we process in particular:

- Personal and contact details (e.g., name, address, date of birth, email address)
- Health data (e.g., diagnoses, pre-existing conditions, treatments)
- Contract data (e.g., insurance number, tariff information, product interest)
- Payment data (if necessary)

### Legal basis for processing

We only process your data when permitted to do so. This is the case, for example, if you have given us your consent, if we need to fulfill your contract, or if we are legally obliged to do so. In certain situations, we also process data to protect legitimate interests, such as to prevent fraud or to enforce claims. We only use your data for advertising and marketing with your express consent. We also only process health data with your consent, for example for risk assessment or premium calculation. You can revoke your consent at any time for the future.

### Recipients of the data

We only disclose personal data if this is necessary for the fulfillment of the consulting and brokerage mandate, legal obligations, or based on legitimate interests. If we use external service providers for data processing, this is done exclusively based on a data processing agreement in accordance with Art. 28 GDPR. These service providers are carefully selected, checked for data protection compliance, and are obliged to process personal data only in accordance with our instructions and in compliance with appropriate technical and organizational measures.

In addition, it may be necessary to transfer your personal data to other recipients, such as authorities, to comply with legal reporting requirements (e.g., social security agencies, tax authorities, or law enforcement agencies).

### Duration of data processing

We store personal data for the duration of the business relationship (initiation, execution, termination) and in accordance with statutory retention requirements. Once the purposes and legal obligations no longer apply, the data is deleted or anonymized.

### Rights of data subjects

- Right to information, Art. 15 GDPR
- Right to rectification, Art. 16 GDPR
- Right to erasure, Art. 17 GDPR
- Right to restriction of processing, Art. 18 GDPR
- Right to object, Art. 21 GDPR
- The objection must be sent to the above-mentioned controller.

### Right to lodge a complaint with a supervisory authority, Art. 77 GDPR
